**Important Medical Information. Please read carefully.**

Welcome to all incoming 6th grade parents!

Although you have received Frost Valley information and forms recently I also wanted to help you get a jump-start on additional medical forms you may need and give you medical information needed to start school in the Fall.

### **\*\*\*\*\* Wyckoff District Medical Information and Forms \*\*\*\*\***

#### **1. Immunizations and Physical Exam**

All entering sixth graders must have a Tdap (tetanus, diphtheria, acellular pertussis) dose given on or after the 10th birthday. At age 11, all students must also have Meningococcal-containing vaccine. Your child's/children's immunizations must be up-to-date in order for him/her to remain in school. **As per the New Jersey Department of Health and Senior Services, your child/children will be excluded from school and school activities if she/he is not in compliance with these requirements by the first day of school. \*\* If your child does not meet the age requirements for the above vaccines a doctor's note is needed with the scheduled appointment date to get the vaccines. This note is only for students who do not meet the age requirements.**

**\*\*\*Please review your child's/children's immunization report before handing it in to the school nurse to be sure the two required immunizations were put on the report by the doctor's office. The doctor's office has the form. There is no special form from the school.** Please check with your pediatrician for additional information regarding these immunization requirements.

**\*\*\*Please send in a current physical examination completed by your child/children's doctor.**

**Due date: By the first day of school.** If you have proper documentation of immunizations and the physical examination prior to the end of the school year please provide it to your son/daughter's elementary school nurse. After the close of school, please either drop the forms off in the main office or mail them to Eisenhower.

#### **2. Wyckoff District Medication Forms**

If your child needs any type of medication for the 2019 - 2020 school year **you and your doctor must complete Wyckoff District medication forms. The district has a separate online check off box for Tylenol, Tums and cough drops. This is only for Eisenhower students.** For your convenience, the Wyckoff District forms can be downloaded from the Eisenhower Middle School web page at [www.wyckoffps.org](http://www.wyckoffps.org), from the nurses' site. The forms located online are the Epi-Pen packet, Asthma

Action Plan, and the Authorization of Medication to be taken at School. All medication forms completed for Frost Valley are not returned to us and you will need our district forms for any medication you would like us to administer during the school year.

**Due date: First day of school.**

*Below are some helpful tips for completing the Frost Valley forms if you have not already filled them out.*

**\*\*\*\*\* Frost Valley Forms \*\*\*\*\***

1. ***The Student Health form*** must be filled out for all students. Must be returned by Friday, September 13, 2019 to your child's 6<sup>th</sup> grade homeroom teacher.
2. You and your physician must complete the ***Written Physician and Parent form*** if you want your child to have any type of medication ( including over the counter medication) while they are at Frost Valley. These forms must be returned to your child's 6th grade homeroom teacher by Friday, September 13, 2019
3. \*\*Do not leave any blank lines. If an area on the form does not apply to your child, please write none or n/ a.

\*\*Please note that the Frost Valley medical forms cannot be used in place of the Wyckoff district forms.

In order for the nurse at Frost Valley to be in compliance with state law governing administration of medication, we request the following:

**Emergency medications** that may be carried by the student are **epinephrine, insulin or, as needed, rescue inhalers**. Emergency medications require the attached Frost Valley medication forms to be completed. The Frost Valley form includes a self-medication release section to allow the student to carry the emergency medication. No other medications can be carried by the student. Please do not pack any medications in your child's/children's luggage.

**All medications** require a doctor's **written** order, with the name of the medication, dosage, and times of administration and must be in the **original, labeled container**. If you do not list the medication on the Frost Valley form, it will not be administered.

**Medication exclusively for Frost Valley must be brought to the Eisenhower Middle School nurse's office no later than Tuesday, September 24, 2019. The Nurse's office is open during the day from 8:00 am to 3:00 pm.**
